**Dear Property Owner** 

On behalf of the Lake Parsippany Property Owners Association (LPPOA) we welcome you to our community. Many of you we have known for years, and many of you will be new faces, but we look forward to meeting all of you, whether it is walking around our lake, at the beach or at one of the many community activities we have planned for 2022.

LPPOA was founded in 1933 and has undergone much change. Gone are the unpaved streets and the summer bungalow community it was back then. We are now a full time community with over 2200 homes. The operation of this Association is governed by a Board of elected/appointed volunteer directors. We have worked tirelessly to create our membership structure and fees to be fair for the entire community. Many Members are in different stages of their lives (those who want to enjoy everything that the lake has to offer and those who may not). Based on beach utilization numbers from last year, the Board has come to realize that a majority of the homeowners aren't interested in beach access. There are different interests, so membership addressed that.

The fee for the 2022 annual property owner's member fee is based on the Basic \$292,852.96 and Amenities Premium \$76,078.12, to be shared by the 2204 property owners in this lake community. The Board has voted to assess a 2022 Member fee to pay for maintenance and upkeep of the LPPOA common property. The Amenities premium rate of \$290.00 is charges for full access usage of LPPOA common property. For homeowners who wish not to use full amenities offered by the association, a reduced rate of \$135.00 is available. The statement will indicate the \$290 amount. If you are interested in waiving access to these amenities, you can pay the reduced amount of \$135. Payment in full is due by March 31; after March 31, all delinquent accounts will be assessed a \$100 late payment charge. Only Property Owners in Good Standing (no balance owed) retain privileges of LPPOA, including the right to vote and the ability to run for open Board positions. Committee participation is open and encouraged for all members. Members, in good standing, will automatically receive 4 member cards. For Property Owners with a larger household of more than 4 members, additional cards provided for *verified* family members living in the home.

All property owners in good standing can enjoy full participation designated by their member plan in the LPPOA. Good standing is defined as members who are up to date with both current year dues as well as all past years' dues. Premium Plan members (i.e., those who have not waived additional amenity access) enjoy the full use of all LPPOA facilities including use of the beach, involvement in Hub Lakes and can sign up to take swim lessons for a nominal fee. We encourage all members in good standing to participate in the many events planned for 2022 such as family fun, sunsets at the beach, community-building activities, cultural celebration events and clubhouse social events. Only Premium Plan Members may purchase day guest passes for the beach. When bringing a guest to the beach remember that you are fully responsible for your guests. While using the lake's facilities you will be asked to provide your membership card as well as other identification that may be requested.

Please remember, your membership is yours, it is *not transferable*. Your membership extends to all permanent occupants of your primary residence. If your Lake property is not your primary residence, any renters of your Lake property must purchase their own Non-Property Owner membership to participate in any LPPOA activities, including fishing and boating.

the many activities open to members in good standing. Upcoming events, announcements and a community calendar can be found here.

At this site you can register and pay for membership. Once you have completed the registration process, be sure to go back in and register all of your family members for activities that interest them as well. Remember that many of the events and activities require online registration; you wouldn't want to miss out!

We encourage you to pay your statement here as it not only saves the Association with bookkeeping fees, but it ensures that we have your email address so that you can receive our monthly News and Views and we can keep you informed about the happenings in our community.

Additional common privileges for Basic and Premium members.

- Fishing from shoreline or from boats (current NJ State Fresh water Fishing License required-Ages 16-69. NJ Freshwater Angling Regulations must be observed/followed)
- Access to sailing, kayak, model yacht regattas, and other member clubs, use of boathouse and boathouse property.
- Boating, with an annual boat tag permitted. Boat storage also permitted for members, basic members must pay for the boat tag(s). Parking and access to boat launch sites included.
- Drewes and Johnson beach and Clubhouse rental for private parties or get together at a discounted rate.


#### Decisions, Decisions

# THE WIDOWS OF MAI ABAR HILL

#### What a difference 100 years can make!

Try becoming a lawyer in Bombay India, in 1916, as a woman!

We read The Widows of Malabar Hill, by Sujata Massey. This is a fictional story of the FIRST woman solicitor in Bombay, Perveen Mistry (inspired by a real historical figure, Cornelia Sorabji).

This book was so well written, it kept us intrigued, while patiently and thoughtfully explaining the different customs of Hindu, Muslim, Parsi (Zoroastrian) and British that all swirled together in India in the early 1900's.

Zoroastrianism is an ancient Persian religion that may have originated as early as 4,000 years ago. Arguably the world's first monotheistic faith, it's one of the oldest religions still in existence. Zoroastrianism was the state religion of three Persian dynasties, until the Muslim conquest of Persia in the seventh century A.D.


Zoroastrian refugees, called Parsis, escaped Muslim persecution in Iran by emigrating to India.

Hindu societies of living in a separate room or behind a curtain, or of dressing in all-enveloping clothes, in order to stay out of the sight of men or strangers.





#### LPPOA DAMS AND DIKES

Throughout history, in all parts of the world, dams built to store water have occasionally failed and discharged the stored waters to inflict sometimes incalculable damage in the loss of lives and great damage to property. Failures have involved dams built without application of engineering principles, but have also involved dams built to, at the time, accepted engineering standards of design and construction. The technology of dams has improved with the increased knowledge of design principles and of the characteristics of foundation and dam materials, and it is generally agreed that safe dams can be built, and existing dams can be safely maintained with proper application of current technology.

In 1933, The New York Daily Mirror, part of

The Mirror Holding Corp., purchased a huge tract of pasture and farmland in Parsippany. They dug out 159 acres and erected a dam and two dikes that formed Lake Parsippany. All three are classified as Class I (High-Hazard Potential) Dams with The Federal Emergency Management Agency (FEMA).

#### FEMA CATEGORIZES DAMS AS FOLLOWS.

Any artificial barrier, including appurtenant works, which impounds or diverts water, and which (1) is twenty-five feet or more in height from the natural bed of the stream or watercourse measured at the downstream toe of the barrier or from the lowest elevation of the outside limit of the barrier if it is not across a stream channel or watercourse, to the maximum water storage elevation or (2) has an impounding capacity at maximum water storage elevation of fifty acre-feet or more.

**Earth dam:** An embankment dam in which more than 50% of the total volume is formed of compacted earth layers are generally smaller than 3-inch size.

**Gravity dam:** A dam constructed of concrete and/or masonry, which relies on its weight and internal strength for stability.

Note: There are many other categorizations. Only LPPOA dam categories listed above.

#### HAZARD POTENTIAL CLASSIFICATION

A system that categorizes dams according to the degree of adverse incremental consequences from their failure or misoperation that does not reflect in any way on their current condition (their safety, structural integrity, or flood routing capacity), and that includes the following categories:

**High hazard potential** - loss of one or more human life is probable

**Significant hazard potential** - no probable loss of human life but possible economic loss, environmental damage, disruption of lifeline facilities, or other impacts

**Low hazard potential** - no probable loss of human life and low economic and/or environmental losses (typically limited to the property of the dam owner).

THE LPPOA MUST COMPLY WITH ALL STATE AND FEDERAL REGULATIONS AND FOLLOW BOTH THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION (DEP), BUREAU OF DAM SAFETY AND FEMA GUIDELINES FOR DAM SAFETY.

These guidelines require that the dams are inspected by an engineer compliant with The Bureau of Dam Safety every two years and must have an Emergency Action Plan (EAP) on file.

The purpose of an EAP is to help save lives and reduce property damage in the event of a dam failure or other uncontrolled release of water.

An EAP is a formal document that:


- **1.** Identifies Potential Emergency Conditions and Specifies Pre-Planned Responses.
- **2.** Provides for Early Notification to Local, County and State OEM Officials.
- **3.** Provides Inundation Mapping of Potentially Flooded Areas. (NJDS)

The National Inventory of Dams (NID) database is now available to the public. The NID was populated using the 116th Congressional District Information. State and federal dam regulators provided their data for inclusion in the database.

In most cases, dams within the NID criteria are regulated (construction permit, inspection, and/or enforcement) by federal or state agencies, who have basic information on the dams within their jurisdiction. Therein lies the biggest challenge, and most of the effort to maintain the NID; periodic collection of dam characteristics from 49 states (Alabama currently has no dam safety legislation or formal dam safety program), Puerto Rico, and 18 federal offices. USACE resolves duplicative and conflicting data from the 68 data sources, which helps obtain the more complete, accurate, and updated NID. Historically, the NID has been published every two years. Starting in 2019, the NID will be updated annually.



#### Lake Parsippany Dam is located between



Johnson Beach and the spillway. The size of the dam is 850ft in length and 13ft high. This dam has Both an "Auxiliary Spillway"

and a "Service Spillway". The dam can discharge lake water at a maximum rate of 514 Cubic Ft/Second. (3,845 Gallons)

**The Auxiliary Spillway** is what most of us see when walking around the lake and is covered

by a foot bridge. This spillway has two "Weir Plates" that can be raised and lowered to control the lake's water level and water flow into Eastmans Brook. During the summer, the gates are kept at a maximum height of 284.67 ft above sea level in

accordance with NJ State regulations. During the odd ending years, the LPPOA requests a "Lowering" permit from the NJ Division of Dam Safety. Lowering the water level is done for several reasons. The first is so that the mandatory inspection can take place. The second is so that the township can clean out the three storm water basins around the lake.

The Service Spillway can be found near the

There is a valve stem
that opens a gate valve
under the dam to allow
for controlled water
flow into the Eastmans
Brook.

**Lake Parsippany West Dike #1** – ID: NJ00356 is located across the street from the Clubhouse and measures 1150ft in length and 8ft high.

Lake Parsippany East Dike No. 2 – ID: NJ00931 is not as visible as the others. It is located at the intersection of Califon Rd and Lake Shore Drive. The dike is 320ft long and 5ft high.





**Fun Fact:** Both the Lake Parsippany Dam and Dike #1, have an asphalt "Cap" on the crest of the dam. Most people mistake this for a walkway or sidewalk, but it is part the dam structure. Therefore, it does not require snow removal by town ordinances during winter months.




# THE DART TEAM IS ON A WINNING STREAK

### SHAMROCK FOAM DOUGH HIDDEN SHAPES TRAY

March's create and play explores loose materials, hidden shapes and tracing, and classic foam dough. Shamrock foam dough is soft, fragrant, and uses just 3 simple ingredients. This simple sensory play recipe whips up in less than 5 minutes. It's inexpensive to make, reusable, just add more shaving cream at playtime, and fun.

We added shimmering gold glitter and shamrock goodies to complete our easy-to set-up St. Patrick's Day activity..

#### Supplies needed for Foam Dough:

- Cornstarch, 14 oz
- Shaving Cream, 10 oz
- Bowl
- Green Food Coloring
- Gold Glitter

Add a full bag of corn starch and 3/4 can of shaving cream. Foam dough tends to dry-out quickly, so we reserved a little. Next, add your food coloring, 10-15 drops.

Now, mix, mix! Encourage your child to



squish it through their fingers and knead it. It's great for sensory stimulation.

For our project, the dough was best more sticky-like because we're molding it and adding decorations. So, we added more shaving cream and a dash of gold glitter. Next, gather your sensory materials and create!

#### Supplies needed for Craft & Play:

- Shamrock Cookie Cutter
- Shamrock Bead Necklace
- Gold Play Coins
- Colored Pasta
- Kids Scissors
- Green Loose Materials, various textures
- Tray (optional any kind will do. Use what you have on hand.)

I purchased a shamrock beaded necklace, cookie-cutter, and gold coins for this activity from Michaels. However, you could easily just use all green loose parts from your craft bin or from odds and ends laying around the house. Sensory play helps children develop words to sensations and strengthen new motor skills through shaping, molding, and mixing.
